VOLUNTARY FORFEITURE

It is hereby agreed by Enterprise Land Title Company Inc and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Douglas M. Ommen is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 381, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, Enterprise Land Title Company Inc is licensed as an insurance agency by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 374, 375, and 381 RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning Enterprise Land Title Company Inc, which alleges the following violations subjecting it to enforcement action by the Director;

1. Enterprise Land Title Company, Inc. failed to record with the City Recorder of Deeds the security instrument (Deed of Trust) within three (3) business days of such closing after receipt of certified funds, thereby violating Section 381.412.1 RSMo (1994),
2. Enterprise Land Title Company, Inc. demonstrated unsound underwriting practices by failing to record with the City Recorder of Deeds the Warranty Deed in a timely manner; thereby violating Section 381.071.1(2) RSMo (1994), causing grounds for discipline under Section 375.141.1 (2) RSMo Cum. Supp 2006,
3. Enterprise Land Title Company, Inc. demonstrated incompetence by losing the Warranty Deed and Deed of Trust, which caused it not to be filed with the City Recorder of Deeds Office, a ground for discipline under Section 375.141.1 (8) RSMo Cum Supp 2006.
4. Enterprise Land Title Company Inc. failed to list Betty Jean Hansmann as their licensed producer within twenty days, thereby violating Section 375.015.2 RSMo Cum Supp 2006, a ground for discipline under Section 375.141.1(2) RSMo Cum Supp 2006.


WHEREAS, Enterprise Land Title Company Inc has been informed of the nature of its violations, of its right to counsel and of its right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline its insurance agency license or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that it understands its rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 07A000118, in lieu of the institution by the Department of Insurance, Financial


Institutions and Professional Registration of any action to revoke or suspend the insurance agency license of Enterprise Land Title Company Inc or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Enterprise Land Title Company Inc, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$2,300.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Enterprise Land Title Company Inc shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than June 6, 2007.


