**VOLUNTARY FORFEITURE**

It is hereby agreed by Mark Vanderheiden and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Linda Bohrer is the duly appointed Acting Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo (2000) and Section 374.764, RSMo (Cum. Supp. 2007) and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Mark Vanderheiden is licensed as a general bail bond agent;


WHEREAS, information has been received by the Consumer Affairs Division

concerning Mark Vanderheiden's violation: Section 374.760 RSMo 2000. Each general bail bond agent shall file, between the first and tenth of each month, sworn affidavits with the department stating that there are no unsatisfied judgments against him. The failure to submit the monthly affidavit subjects Mark Vanderheiden to enforcement action by the Director;


WHEREAS, Mark Vanderheiden has been informed of the nature of his violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his general bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000925, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail general bail bond license of Mark Vanderheiden or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Mark Vanderheiden, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$300.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Mark Vanderheiden shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than December 19, 2008.
