VOLUNTARY FORFEITURE

It is hereby agreed by Edward Walker and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo (2000) and Section 374.764, RSMo (Supp. 2011) and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Edward Walker is licensed as a bail bond agent;

WHEREAS, information has been received by the Consumer Affairs Division Concerning Edward Walker's violation of Section 374.702.2, RSMo (Supp. 2011) by failing to surrender his bail bond license while employed by the St. Clair County Sheriff's Office between April 24, 2011 and July 12, 2011. Such violation is a ground for discipline under:

Section 374.755.1(6) – Violation of any provision of or any obligation imposed by the laws of this state, department of insurance, financial institutions and professional registration rules and regulations...; and

subjects Edward Walker to enforcement action by the Director;

WHEREAS, Edward Walker has been informed of the nature of this violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline the bail bond license of Edward Walker or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail bond license Edward Walker or to impose any other penalties provided for by statute for the above-described violation, after being afforded the opportunity to consult legal counsel, Edward Walker, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$450.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Edward Walker shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than May 31, 2012.
